Local Law 157: What You Need to Know

After two fatal gas explosions in 2014 and 2015, New York City Council passed Local Law 157 in 2016 mandating the installation of a Natural Gas Detector in all residences in NYC. The legislation aims to enhance safety measures to detect gas leaks. The final rule was not published until February 15,2024 after national safety standards had been established by the NFPA (National Fire Protection Association). Requiring compliance by May 1st of 2025, Local Law 157 mandates that where a fuel-gas burning appliance is installed within a dwelling, a gas detector must be installed within 12 inches of the ceiling, and at least 3 feet away but no more than 10 feet away from the gas appliance.

When Does the Law Take Effect?

The law went into immediate effect; however, all buildings have until May 1st of 2025 to comply with the law.

Which buildings must comply with Local Law 157?

As defined by the NYC Housing Maintenance Code, properties that must comply with Local Law 157 include Class A and B Multiple Dwellings as well as Private Dwellings.

- Class A multiple dwellings includes condos, co-ops, multifamily rental buildings, and one- and two-family houses
- Class B multiple dwellings transient housing properties (i.e., hotels, lodging houses, and dormitories)
- Private dwellings typical single-family homes or smaller residences

What type of gas detectors comply with Local Law 157?

Gas Detectors can be Battery Powered, Hardwired or Plug in devices but they must meet all the following requirements:
